# **<u>1. EXECUTIVE SUMMARY</u>**

# **1.1 INTRODUCTION**

Rajkiya Sanatakottar Mahavidyalaya Bazpur is a co-educational institution located in the Tarai region of the Himalayas, near the tourist destination Nainital. It is affiliated with Kumaun University Nainital and offers multidisciplinary courses under three faculties: Arts, Science, and Commerce. The Faculty of Arts includes six departments, while the Faculty of Science comprises five departments. The college started Post Graduate classes in Science subjects in 2015 and was given permanent Post Graduate College status by the Government of Uttarakhand in 2017. It also offers a self-financed P.G. Diploma in Yoga and Holistic Health and serves about 1200 students every year.

In addition to regular programs, the college is an approved study center of Uttarakhand Open University since 2017 and serves as a research center of Kumaun University with almost 20 research scholars registered in various departments. The college has a dedicated team of 26 teachers and 18 non-teaching staff.

The college's primary goal is to provide comprehensive education to students from different communities and localities. Its location in the Tarai region of the Himalayas makes it an ideal place for students seeking a peaceful and serene environment for learning. With its multidisciplinary courses, dedicated team of teachers and staff, and research facilities, Rajkiya Sanatakottar Mahavidyalaya Bazpur strives to provide its students with the best possible education and a bright future.

- The college serves around 1100 students annually with a majority being girls (over 65% in the current session).
- The faculty is dedicated and competent, with almost all departments having the sanctioned number of faculty members who possess a Ph.D./NET and have publications to their credit.
- The faculty and students share a cordial and courteous relationship.
- Undergraduate tuition is free, and postgraduate fees are kept low.
- Government schemes that benefit students of deprived classes (SC/ST/OBC) are transparently provided.
- Admission is merit-based, and the college is co-educational.
- The college is a study center for distance learning through Uttarakhand Open University (UOU), allowing working students to participate.
- The college offers access to an e-library and Distant Classroom Education (EDUSAT).
- The career counseling and placement cell of the college runs counseling sessions for the students about their better career options.
- The college has good infrastructure, including well-equipped laboratories and a library, and an ecofriendly environment.
- The college fulfills its social commitments via outreach activities under the steering of NSS and Rover Rangers.
- The college has an NCC unit that provides training to the students to join the army and to inculcate the feeling of serving the nation first

#### **Institutional Weakness**

- College offers only traditional courses at UG and PG levels.
- Inaccessible access to govt. schemes regarding free travel for girls students due to the college's location on a village road and lack of public transportation.
- No separate lecture room facilities for PG students in all departments.
- No separate laboratory for PG students in science.
- Insufficient seating capacity and number of instruments available in labs for student strength.
- Lack of proper research equipment.
- Limited subscription to Journals.
- No canteen facility in the college.
- Lack of funds to facilitate laboratories and libraries.
- Lack of independence to make decisions in student welfare

- The college has a vast exposure to minority communities and can work for their socio-economic growth

- **The col**lege has a diverse student population with students coming from different socio-economic backgrounds, which presents a challenge in providing equal opportunities and platforms to all students.
- Limited infrastructure facilities may hinder the implementation of the National Education Policy 2020 in the college.
- In order to compete as a leading institute in the current era, the college needs to offer more vocational courses as they are becoming increasingly popular among students.
- The location of the college in a rural suburban area may make it difficult to attract students from urban areas.

## **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

Effective curriculum delivery is crucial for maximizing student learning outcomes. This involves ensuring that the curriculum is relevant, engaging, and effectively delivered through alignment with educational goals, clear learning objectives, varied instructional strategies, appropriate assessment tools, regular feedback, and ongoing professional development for teachers. At this college, the curricular aspects of courses are governed by Ordinances of Kumaun University Nainital. The college follows the prescribed curriculum designed by the university, and cross-cutting issues are an integral part of the curriculum.

To ensure effective implementation of the curriculum, the college has well-structured and documented processes that enable communication and dialogue between teachers and students. At the beginning of the academic session, meetings are held, and different committees are made to distribute work among the teachers. Plans are also made to maintain discipline during the admission process, and a timetable is created that ensures a balanced distribution of tutorials and lectures in the best interest of the students.

The college takes additional efforts through National Social Service (NSS) to make students sensitive towards social issues. Activities such as tree plantation, poster exhibition, blood donation camps, and adventure camps are organized under the banner of NSS. The institution also has a career counseling cell that organizes frequent classes and programs throughout the session.

To ensure that learning outcomes are achieved, teaching strategies are modified and adjusted as per individual requirements of the students. The performance and progress of the students are regularly appraised to ensure their holistic development. Co-curricular activities provide a platform to instill values in students, and various societies such as NSS, Rover Rangers, Eco Club, and NCC not only motivate students but also provide a platform to help them become good citizens of the country.

Continuous internal evaluation ensures that teaching strategies are modified and adjusted as per individual requirements of the students. Feedback related to teaching and curriculum is collected and analyzed for quality enhancement from various stakeholders by the college's Internal Quality Assurance Cell.

#### **Teaching-learning and Evaluation**

The faculty members at GPGC Bazpur College are cognizant of the diverse range of abilities and skills that students possess in the classroom. They offer support to improve the teaching and learning process, organizing various workshops, conferences, and add-on courses for students. These events feature renowned speakers and resource persons to keep students informed of the latest developments and expand their knowledge. Furthermore, the college encourages students from all departments to undertake research and publish papers in various journals. The college is dedicated to providing quality, inclusive, and multidisciplinary education to a diverse student population. The teaching-learning process is outcome-oriented, and the college prepares students for their professional lives by equipping them with knowledge and skills.

To foster participative learning beyond the classroom, GPGC Bazpur College conducts community service activities such as NSS Camps, blood donation camps, tree plantation drives, and NCC programmes. These activities contribute to the holistic development of students. The college is equipped with a variety of ICT-enabled tools and computer labs, and the library is semi automated, with access to a multitude of online journals to facilitate research. The faculty members are encouraged to adopt pedagogies that promote participative learning and problem-solving. The college leverages ICT tools to the fullest extent possible to

achieve these goals and to benefit from the integration of the institution with the global educational ecosystem.

To ensure the all-round development of its students, the college offers opportunities for sports, cultural activities, and community service. The college has implemented an internal assessment system that provides ample opportunities for students to enhance their academic grades. The college also has a well-defined grievance redressal mechanism in place. Finally, the college prominently displays all program and course outcomes and disseminates them adequately through various channels.

#### **Research, Innovations and Extension**

The college encourages faculty members to engage in high-quality research and submit research proposals, resulting in numerous publications in peer-reviewed journals, book chapters, and books across various disciplines. Faculty members participate in various professional development programs such as FDPs, refresher courses, workshops, and seminars to improve their teaching, learning, and research skills. The college's departments organize seminars and invited lectures to provide students with exposure to the latest learning and research methodologies.

One of the college's key strengths lies in its commitment to fostering the holistic development of students, nurturing them to become responsible citizens. The institution ensures equal opportunities for disseminating knowledge and delivering quality education to all sections of society. Engaging in co-curricular, extracurricular, and extension activities through departmental associations, NCC, and NSS, the college plays an integral role in various extension activities within the local community. These activities aim to instill vital human values, raise awareness about social issues such as cleanliness, environmental protection, gender equality, anti drug etc. Rallies, skits, essay writing, poster making, slogan writing competitions, quizzes, and other initiatives are organized to promote these causes.

The NSS conducts one-day and seven-day camps, providing students with the opportunity to actively serve the community through diverse activities and awareness programs. NCC cadets conducts swachta pakhwada, drill, Republic Day Parades, and celebrates national festivals etc, where they gain insights into India's rich cultural diversity, history, patriotism, national integration, brotherhood, communal harmony, and experience the traditions, customs, languages, and cultures of various states.

The college has also organized events such as blood donation camps, and environment awareness initiatives, further contributing to the welfare of society.

#### **Infrastructure and Learning Resources**

Rajkiya Snatakottar Mahavidyalaya Bazpur has transformed from a U.G. college for arts and commerce to a Post Graduate College offering degrees in Arts, Commerce, and Science. The college is spread over 11.2 acres of land and has a covered area of 9306 square meters.

The college has sufficient lecture rooms and all the lecture theaters are equipped with basic facilities like electricity and seating arrangements. The laboratories are designed to meet government norms and safety standards. There are 5 well-equipped laboratories for both undergraduate and postgraduate students. In addition, the college has recently introduced ICT-enabled facilities in 5 of the lecture theaters, increasing the total number of ICT-enabled lecture theaters to 8.

There are separate staff rooms for all the 12 departments, where students can interact freely with the teachers. The college also has a computer lab with internet facilities for students. The college has a separate central library with a reading room. The library is semi-automated and uses the E-Granthalaya Library Management System. It has over 10,000 books on varied subjects, 60+ national and international journals, and access to thousands of online journals through the N-LIST database.

The college has a multipurpose hall complex that can be used for cultural activities, seminars, conferences, and indoor games. The college also provides sports facilities with a large playground, indoor games facilities, and special uniforms for participation in different events.

The college runs a P.G. Diploma in Yoga program and has well-equipped facilities to train students. The Yoga department has produced many proficient trainers who are serving the society working in Govt. Sector in general and Private Sector in particular. The college also has equipment like Tabla and Harmonium for cultural activities and a separate committee to organize cultural events and programs.

The college is funded under RUSA Phase 1 scheme of MHRD and has established an e-library in the college. The college encourages teachers to use e-books and e-journals to improve the teaching-learning process. The college has updated its bandwidth from 2 mbps to 100 mbps in the last five years and has around 40 computers

#### **Student Support and Progression**

The Department of Social Welfare sanctions scholarships for SC, ST, and economically weaker sections, which are beneficial to students at the college through both central and state government scholarships and freeships. The college assists students in securing scholarships by coordinating with the Department of Social Welfare. The college regularly engages students in programs aimed at improving their soft skills, language and communication skills, life skills (including yoga, physical fitness, health and hygiene), and ICT/computing skills to enhance their capacity and skills.

To promote students' personal and professional development, the Career Counseling Cell, NSS Wing, and departments organize seminars, motivational talks, and guest lectures on interpersonal skills. The college strives to create a gender-sensitive and congenial campus environment and has a transparent mechanism for timely redressal of student grievances, including sexual harassment and ragging cases. The college has an internal cell dedicated to addressing women-related grievances and preventing incidents of abuse or sexual harassment. New students must fill out an Anti-Ragging Form signed by their guardians, and an Anti-Drug Club was established to promote a healthy and intoxication-free campus environment.

The college encourages student participation in national, state, university, and inter-collegiate sports events. National, state, and local level seminars and webinars provide students with ample exposure in their fields of study. The college magazine provides a platform for students to express themselves and articulate their thoughts. The elected members of the Student Union coordinate events such as the College Annual Day and other campus activities. Alumni gather socially to provide logistic support and extend their full cooperation to the college

#### Governance, Leadership and Management

The mission of the college guides towards the development of strategies and perspective plans for the

fulfilment of vision.

- The decentralized functioning amplifies the efficiency of operation of the college.
- The varying personnel task specific requirements and performances are effectively monitored and managed.
- The college follows the policies, appointment and service rules laid down by the State Government of Uttarakhand and the procedures directed by the affiliating University.
- The academic functioning is further divided into 12 departments and the administrative set up of the college comprises office staff and committees.
- E-governance is effectively implemented to ensure time-saving creation of data, efficient decision making and its quick availability.
- The welfare measures taken by Government of Uttarakhand are applicable on the employees of the college.
- The purchases in the college follow the procedure mentioned in the procurement rules laid for the government bodies.
- The Internal Quality Assurance Cell (IQAC) plays a pivotal role in the enhancement of the quality of education.

IQAC periodically assesses the student requirements and satisfaction with the facilities provided through the feedbacks

#### **Institutional Values and Best Practices**

The college has taken steps to address women's issues, such as establishing an Women grievance redressal Cell as per National Women Commission guidelines and providing a separate common room for girls. Equal participation of both boys and girls in every activity is encouraged.

- CCTV cameras have been installed for student surveillance and adequate security measures have been implemented.
- The college has made special efforts to reduce power consumption and encourages the use of LED lights.
- Measures have been taken to ensure that the campus is made into a plastic-free zone.
- The institution has built ramps/lifts for easy access to classrooms and disabled-friendly washrooms, and provides an inclusive environment for everyone.
- An environment audit is conducted to identify, document, and monitor environmentally important components in the campus.
- The campus is lined with trees and lights, and their maintenance is looked after by the campus maintenance committee.
- Students and employees are sensitized to their constitutional obligations, values, rights, duties, and responsibilities as citizens.

The college has adopted two best practices to promote the development of critical thinking and socialemotional skills required to become a responsible citizen. These practices include:

An orientation program at the beginning of each session to introduce students to the college's values, goals, and expectations.

The Clean and Green campus initiative, which promotes the enhancement of green areas on the campus and encourages students to take responsibility for their environment.

Additionally, the college has a distinctive character in terms of its awareness programs, which promote various social and environmental issues and encourage students to become more aware and responsible members of society.

From the academic session 2022-23, the college incorporated the NEP curriculum established by Kumaun University Nainital. The College has defined and assigned multidisciplinary/interdisciplinary courses, and it is regularly reviewing and adding new courses in accordance with the structure established by Kumaun University Nainital.
2. Academic bank of credits (ABC):	Starting from the academic year 2022-23, the college

	has implemented a compulsory registration process with the Academic Bank of Credit (ABC) for all students enrolled under the National Education Policy (NEP). Currently, all NEP students studying at the college have successfully activated their ABC accounts.
3. Skill development:	The college offers skill development courses aligned with the guidelines set by Kumaun University Nainital. Currently, vocational courses are available in areas such as Computer Science, Hindi Writing, Voting Rights (offered by the Faculty of Arts), Intellectual Property Rights (offered by the Faculty of Science), and Financial Literacy (offered by the Faculty of Commerce). Additionally, the college is actively working towards introducing skill development programs in subjects like Zoology, Mathematics, and Commerce. To enhance learning opportunities, students at the college are provided education through online platforms like SWAYAM. Moreover, the college actively promotes and supports student participation in apprenticeships. In this regard, the National Apprenticeship Promotion Scheme is being popularized among students, aiming to provide them with valuable practical experience and career-oriented skills.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The new curriculum, based on the National Education Policy (NEP) of 2020, incorporates the Indian knowledge system as an essential component. In alignment with the syllabus of the Kumaun University, several courses have been designed to integrate the Indian knowledge system. These courses include subjects such as Vedas, Upanishads, Gita, Puranas, Dharmshastras, Ramayan, Mahabharat, Panchatantra and Yoga. In addition to the academic curriculum, the college places significant emphasis on co-curricular activities such as NCC (National Cadet Corps), NSS (National Service Scheme), and other extracurricular engagements. These activities play a vital role in integrating and promoting the Indian knowledge system within the institution.
5. Focus on Outcome based education (OBE):	The college places a strong emphasis on achieving specific outcomes after the completion of each course. To facilitate this, college has developed clear and concise program outcomes (POs),and course outcomes (COs). These outcomes are also communicated to students during orientation

	programs at both the institutional and departmental levels. The college is committed to measuring the levels of attainment of these outcomes for all programs and courses through different methods of evaluation. By doing so, we strive to ensure that every student achieves their full potential and is well- prepared for their future endeavors.
6. Distance education/online education:	online teaching has played a crucial role, particularly gaining significant popularity during the Covid-19 pandemic when schools and colleges were compelled to shut down after March 2020. Online classes were conducted during the 2020-21 session. Online teaching emerged as an essential mode of education during the pandemic, enabling seamless learning without the need for physical presence in a specific location for both students and teachers. In order to accommodate experts from various institutions, the college offers online classes through Edu-SAT. This platform allows the college to tap into a pool of diverse expertise and provide students with a comprehensive learning experience. By utilizing Edu- SAT, the college ensures that students have access to a wide range of knowledgeable educators, enriching their educational journey. College has a center for Uttarakhand Open University (UOU), utilizing innovative educational programs and various modes of communication technology, along with contact sessions, to enhance the effectiveness of distance learning. The objective of the uttarakhand Open University is to address the educational requirements of targeted groups, fostering the development of skilled and knowledgeable individuals for the rapid progress and advancement of the State.

#### **RESPONSE:**

Effective curriculum delivery maximizes student learning outcomes by ensuring the curriculum is relevant, engaging, and effectively delivered through alignment with educational goals, clear learning objectives, varied instructional strategies, appropriate assessment tools, regular feedback, and ongoing professional development for teachers. Curricular aspects of courses of the College are governed by Ordinances of Kumaun University Nainital. For effective implementation of the curriculum we have well-structured and documented processes that enable communication and dialogue between teachers and students.

#### Two Tier systems to Plan Effective Curriculum Delivery:

To ensure effective curriculum delivery in a structured and transparent manner the college has developed a two tier system comprising of a Curriculum Delivery Planning Committee (CDPC) at college level and Departmental Sub committees (DSCs) in all departments.

On recommendation of IQAC, the Principal RMB formed these committees on 22/12/2018 by order no 25.

**Departmental Sub committees (DSCs):** DSCsare formed in all the departments. All the teachers of department are members of this committee. The HOD is the convener of this committee. The main function of this committee is to make plan for effective delivery of curriculum and to implement the plan. DSCs also prepare departmental timetable, programme outcomes and course specific outcomes. This committee is also responsible for carrying out different academic activities in the department. DSCs of all the departments hold meetings at the starting of the semester/year.

**Curriculum Delivery Preparing Committee (CDPC):** All HODs and Examination in-charge are members of this committee. The committee is headed by the Principal. Main function of this committee is to monitor the implementation of curriculum delivery planes made by DSCs throughout the semester. CDPC holds meetings at regular intervals to follow up the plan. Necessary instructions and advisory are issued to departments time to time.

A well-documented Curriculum Delivery Plan provides a point of reference to objectively measure the progress in curriculum delivery aspects of departments and college. It also plays important role in bringing transparency in the process of internal evaluation and assessment.

University notifies a broad framework of the academic calendar which is followed by the college. Teachers use this academic calendar along with the notified scheme of each paper to plan teaching and engagements with the students. The implementation of teaching plan according to academic calendar is ensured by college administration. College ensures minimum 180 days of teaching in an academic year. CDPC of college meet twice in a semester to follow-up the implementation of plan as per the academic calendar.

For semester classes each theory paper internal assessment conducted periodically (in the form of class tests and/or assignments/ group discussion/ oral presentation/ overall performance) during the semester period. Marks allotted to internal assessment are 25% of total marks. The college ensures that the notification for internal assessment is followed in letter and spirit. Every faculty follows the relevant guidelines in this regard. The marks obtained by the students are uploaded to University examination portal at the end of each semester to ensure transparency in the entire process.

#### **1.3 Curriculum Enrichment**

Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum

#### **Response:**

The college strictly follows the curriculum designed by the Kumaun University. These cross-cutting issues are an integral part of the prescribed curriculum which includes papers offering deeper insight and outlook related to them. This not only helps students develop a well-rounded perspective but also prepares them to be responsible and ethical professionals who are conscious of the impact of their actions on society and the environment.

Integrating professional ethics into the curriculum ensures that students are aware of the ethical principles and values that guide their profession. The curriculum of M.COM and B.Com mainly focuses to inculcate these values among the students, having topics like business ethics and corporate social responsibility, ethics and management, ethical decision making, developing ethics programs, auditing and corporate governance, business environment, globalization and liberalization, socio-cultural environment, etc.

Integrating gender into the curriculum acknowledges the role that gender plays in shaping the experiences of individuals and society as a whole. It helps students to understand the impact of gender stereotypes, biases, discrimination, and to develop a gender-sensitive approach. For this purpose, college has a special paper named "Gender and Society" in sociology which deals with the social construction of gender, health status, a sociocultural perspective of gender, gender discrimination, woman and the economy, the gender gap, and women in polity topics. The syllabus of history includes gender sensitization with topics of the marriage system, the status of women, society, trends in religious history, and gender. In Political science, there are many topics like feminism, caste, class, gender, the region in Indian politics, rights of women, gender perspective, strategies for women's empowerment, women and development, work and entrepreneurship, women and society, women empowerment, women health and local issues, the role of women in government, etc. which deals with gender sensitization.

Integrating human values into the curriculum emphasizes the importance of human dignity, respect for diversity, and social responsibility. Most of the syllabus of Hindi and Sanskrit deals with these topics to inculcate human values among the students.

Integrating environment and sustainability into the curriculum emphasizes the need to address the pressing environmental challenges facing the planet. It helps students to develop an understanding of the interconnectedness of the environment, economy, and society, and to adopt a sustainable and responsible approach to their profession. The syllabus of botany and zoology includes ecology and environmental biology, animal behavior, environmental science and applied zoology, wildlife conservation, biostatics and economic botany, sustainable development, plant resources, conservation, etc.

In addition to this, College conduct various activities such as essay writing, quizzes, poster making, debates, symposiums, seminars, assignments, presentations, field visits, social interactions, workshops, etc. The purpose of these activities is to instill these values and cross cutting issues among the students, enabling them to practice them in their daily lives and integrate them into their behavior. Teachers of the college integrate issues of professional ethics, gender, and human values in teaching as far as possible.

#### **2.3 Teaching- Learning Process**

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

**Response:** 

Effective teaching is an essential aspect of education that helps students to achieve a higher level of knowledge. At the college level, the teaching and learning process is centered around the students. This approach involves the students in various academic and co-curricular activities both within and outside the classroom. To ensure that students are adequately prepared for the future, teachers employ the following methods of teaching and learning to reach students of different levels, including the use of ICT tools.

**Experiential learning**: This approach involves assigning field work, projects, assignments, and seminar presentations that are evaluated as a part of internal assessment. In the Faculty of Science, P.G. fourth-semester students submit a dissertation as a mandatory part of their course. Experiential learning methods enable students to apply theoretical knowledge in real-world settings, promoting practical skills development.

**Participative learning**: It involves encouraging students to share information, learn from each other, and work together to solve common problems. Group discussions and debates are used to deliver curriculum objectives. The college has active departmental associations that organize programs like chart competitions, slogan making, painting, essay writing, etc. These programs help to develop students' communication, teamwork, and leadership skills.

The college also organizes invited lectures and visits to the college, providing a chance for students to interact with eminent academicians and scholars. Extension and social activities are organized regularly for students as part of an effort to develop a social conscience. These activities include interacting with people to create awareness about social problems like the use of alcohol/drugs, female feticide, etc. Through these interactions, students gain a better understanding of society and its problems

**Problem-solving methodologies**: Problem-solving methodologies are also used to encourage students to believe in their ability to think critically. Methods such as problem description, problem discussion, class tests, and dissertations are used to foster independent thinking and problem-solving skills. In addition, special revision classes and remedial classes are conducted for students who are facing difficulties in learning. A counseling facility is also available to students facing learning difficulties and emotional stress

**ICT- Enabled Teaching**: ICT-enabled teaching is an essential aspect of the teaching and learning process at the college. The college has set up a conference room with smart digital teaching devices, five projector rooms, a presentation room with an interactive panel, a computer lab with the internet, and an EDUSAT classroom through which teachers can use ICT techniques for teaching. The post-graduate students are encouraged to learn the use of Powerpoint presentations for departmental seminars. During the COVID-19 pandemic, when physical classes were suspended, ICT tools were the only instruments available for teachers and students to complete the teaching-learning process. Teaching apps like Zoom, Google Meet, and Google Classroom were commonly used by students and teachers for their daily classes.

Teachers utilize freely available online resources such as video lectures, articles, and books to provide students with a more profound understanding of subjects.

#### **2.5 Evaluation Process and Reforms**

#### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

**Response:** 

The college adheres to the evaluation guidelines provided by the University for classroom assessments, attendance, assignments, and projects. The internal evaluation process is conducted in a transparent and closely monitored manner. As a constituent college of Kumaun University, Nainital, our institution follows the recommended evaluation system where 75% weightage is given to external assessments and 25% to internal assessments. This includes assignments, class tests, presentations, attendance, dissertations, and viva-voce exams. However, there is no internal assessment for the year system.

At the start of each academic year, an orientation program is conducted to educate students about the evaluation process and the tentative schedule of assessments. The finalized internal assessment marks are shared with students by the concerned teachers, and any discrepancies are resolved quickly.

Continuous evaluation ensures that teachers and students remain in regular communication to minimize delays in grievance redressal. The evaluation process is transparent and unbiased, with the students' performance in internal assessment assignments being discussed with them. Student feedback and suggestions are collected to ensure transparency in the internal evaluation process.

The university conducts end-semester examinations, and the evaluation is carried out by faculty members from other colleges or universities. To ensure impartiality, faculty members are assigned papers from other colleges to evaluate, and the results are shared with students through the university portal.

Grievances related to examinations and assessments can be reported to the concerned teacher, Head of Department, or Principal in that order. The Examination Committee of the College addresses any examination-related grievances, and the process is time-bound to ensure prompt resolution. If a student has grievances related to evaluation, they can request a photocopy of their evaluated answer sheet under the RTI Act, 2005. The Examination Committee also deals with problems like errors in marks sheets,

loss of mark sheet, and improvement exams.

The committee maintains a register of reported grievances, and students can approach the "Controller of exam" of kumaun university through the Exam In-charge and the Principal of the College. The university also offers students the opportunity to review their grades and participate in Improvement Examinations if they meet specific requirements. The Exam Committee of the College is committed to resolving examination-related grievances with accountability, making the process transparent, time-bound, and efficient.

In summary, the college follows the prescribed evaluation system and ensures a transparent, efficient, and time-bound assessment and grievance redressal mechanism. The evaluation process is transparent and unbiased, and continuous evaluation helps students participate in academic activities. Grievances related to examinations and assessments are promptly addressed, and the Examination Committee of the College is fully committed to solving any issues with utmost care and accountability.

Program Outcomes, and Course Outcomes are the basic set of concepts, knowledge and skills acquired by the students, are supposed to acquire after successful completion of the course/programme. These basic set of concepts identifies and suggests the skills/ knowledge that the student ought to possess to be academically capable and competent in the industry.

Being a constituent college of the Kumaun University, Nainital the college adopts the programme outcomes and course outcomes prescribed by the former. The syllabus of all the programme along with the POs and the COs of all the individual courses offered by the departments are displayed on the college website GPGCBAZPUR.IN. Program outcomes are highlighted through career options open to students after completion of the programmes. Also, the information sent by the University about revisions is duly conveyed to the students. Meeting of Departmental Sub Committees is held at the beginning of the academic year to allocate subjects and communicate POs, and COs to each of the faculty members. The college conducts an orientation programme where students are informed about the basics such as the facilities provided by the college, reading the timetables, obtaining IDs and an explanation about the general structure of the programs offered. This is followed by departmental orientations where the course outcomes are explained to the students in detail.

The faculty continuously initiates the process of organizing seminars and workshops where the students

get the opportunity to interact with professionals, expert in their areas. The basic idea behind every programme is to impart knowledge and skills; facilitate an in-depth understanding of the relevant concepts; and motivate students to be learners for life.

The direct assessment of the POs and COs is monitored through their performance in the internal exams, class performance, participation in other activities and university exams conducted in college.

#### **Response:**

The attainment of program and course outcomes is evaluated through both formal and informal means. The most direct measurement is provided by the examination system where we are bounded by the requirements of the Kumaun University Nainital, which gives 75% weightage to the end-semester examination conducted by the university and 25% to the internal assessment done by the respective teacher. The system of internal assessment (IA) provides us some flexibility with respect to the exact manner of evaluation and method of assessment employed. Frequent assignments using MCQs, long answers, presentations, projects, quizzes, etc. are used to measure course outcomes effectively. Departmental council events, extension lectures; college society events, extracurricular activities etc. contribute to the achievement of the programme and programmespecific outcomes which aim to produce graduates equipped beyond the academic curriculum. The themes for seminars, workshops, debates and discussions, dissertations etc. which are organized by the departments from time to time are chosen in the light of course outcomes to ensure that the students understand the subjects through their first hand experiences. Student progression is another measure of outcomes. Many of our societies prepare students for careers in civil services and corporates. Student feedback reveals the gaps and issues faced by them. Immediate redressal of these issues furthers the effective attainment of academic outcomes. Each year, numerous students leave college for higher studies to other universities and colleges. Faculty members assist them in this regard by providing letters of recommendation. #### **Response:**

Rajkiya Snatakottar Mahavidyalaya Bazpur is evolved from a U.G. college for arts and commerce to a Post Graduate College offering U.G., P. G. and research degrees in Arts, Commerce and Science.

The college has its own campus with an area of 11.2 acres. College has a covered area of 9306 square meters. The following infrastructural facilities embellish the academic and non-academic transactions in the college:

- 1.College has sufficient number of lecture rooms. All the lecture theaters are equipped with common facilities like electricity, seating arrangement etc. Lecture theaters are made according to government norms and full fill general safety norms.
- 2. Laboratories: College has 5 laboratories equipped with all facilities required for U.G. and P.G. courses. Laboratories are made according to government norms and full fill general safety norms.
- 3. **Class rooms with ICT enabled facilities**: College 5 lecture theaters with ICT facility recently. Now college has total 8 lecture theaters with ICT enabled facilities.
- 4. All the 12 departments have their own staff rooms where students can have free interaction with the teachers. All the staff rooms have attached lavatories.
- 5.Computer lab was established in college in March 2020. Lab has 07 computers for use of students. Lab has internet facility.
- 6. Library: College has a separate central library with attached reading room. The library maintains over 10061 books, over 62 volumes of journals and subscription of N-List. Library has library management system **E- Granthalay** to facilitate students.
- 7. Separate rooms are provided to IQAC, NCC, NSS, Examination Committee.
- 8. **Multipurpose hall**: The college has Multipurpose Hall Complex. The Complex is spread over an area of 3515 sqare meter. The complex has a multipurpose hall which can be used as auditorium for organizing cultural activities, seminars, conferences etc as well as for organizing Indore games.
- 9. Separate girls common room and student union room is maintained.
- 10. Sports Facility : College has large playground with facilities like cricket practice net, volley ball, football, javelin throw, races track etc. College has indoor games facility viz badminton court, Drop Roball, Kabbadi Mat /Taikwando Mat, Table Tennis etc. The college provides track suits, T-shirts, lowers for practice and special/separate uniforms for participation in different events like Inter-collegiate level competitions, etc. to the sportspersons who also get due TA/DA,

refreshments for participation in tournaments/ sport events, the winners of which are separately felicitated with mementos, Trophies, Cups, etc at the College level.

The College runs the programme, P.G. Diploma in Yoga since 2017. Presently, 12 students are enrolled. The Yoga department has well equipped facilities to train students and produced many proficient trainers who are serving the society working in Govt. Sector in general and Private Sector in particular.

For culture activities, the college has equipment like Tabla, Harmonium etc. and to conduct cultural programmes, separate committee is formed which organizes cultural events and programmes time to time, particularly during Republic Day, Independence Day, Gandhi Jayanti, Annual Day, Sardar Patel Jayanti and other important days

#### **Response:**

The college has central library for the access of all the students and teachers of all departments. Students and staff members can have an open access to the new books and the catalogues. In library internet facility is available to access e- resource by students and teachers.

The Library is semi-automated. The Library is using **E-Granthalaya**, a Library Management System (LSM) developed by NIC since 2019. All students are registered in E-Granthalay.

The library maintains over **10,000+ books** on varied subjects and has subscription to print version of **60+ national and international journals.** 

Apart from the in-house collection, the library has full access to thousands of **journals online through N-LIST** databases. N-list is a comprehensive database where users of our College (all students, research scholars and teachers) can access more than **6000+ e-journals**, **199500 e-books** through the National Digital Library. It covers all the disciplines i.e., Pure Science, Social Sciences and Humanities Including Languages and Linguistics.

The college has been funded under RUSA Phase 1scheme of MHRD. Through this scheme the college has established e-library in the college. Every year, new books are purchased for library according to the demands of departments and the syllabus.

A reading room is attached with the library so that students and teachers can read books, magazines and newspaper in the free time. The college is encouraging the teachers to use e-books and e-journals which improve teaching-learning process of the college.

The college has almost 40 computers, which were purchased time to time to update according to fulfill the requirements of the institution under different budget scheme. The departments, library, computer lab, and office are provided with computer and printer.

- Initially there were only 7 computers in the college in 2017
- College have purchased 3 computers in 2018
- 13 computer and printers were purchased in 2019 for computer lab.
- 12 computers with printers were purchased under RUSA phase I in year 2021

Moreover the institute has added projectors in the classrooms for interactive learning. They are frequently used for online classes, webinars, seminars and workshops whenever needed. Efforts are being made to equip more departments and classrooms with IT facilities.

- Initially there was only one projector in EDUSAT.
- In year 2019 college purchased projector for seminar room.
- In year 2021 departments of science faculty were equipped with the projector under grant received from district authority.

Internet plans for college also get updated when required. The college has regularly updated its IT facilities by enhancing the band width/Speed of internet as per the increasing needs of institution and the availability of the advanced technology

. The college has updated its 4G internet connection for better speed/bandwidth and the technology for internet. All the departments of the college have been equipped with computers & internet facility. Teachers use them regularly for their academic purposes. Teachers give lectures through PPT to make teaching –learning more interesting. Important/relevant website-recourses are communicated to students for further enriching/expanding their knowledge. PG students use ICT for PPT for assignments/seminars in internal examinations We are on the way to soon provide wi-fi facility to students

Students are continuously encouraged to use existing infrastructure of computer labs and projectors in the classrooms to give presentations

- College regularly upgrades and updates its IT facilities. In 2017 only 4 mbps speed was available but at present the internet bandwidth of the institute is 100 Mbps.
- College department, computer lab, library, reading room and admin office is well-connected with the internet facility and connectivity for its smooth functioning.
- Internet bandwidth based on the requirement the institute keeps upgrading timely.
- Workshops, extension lectures by subject experts, ICT based lectures, and power point presentation (PPT) methods are adopted by the faculty time to time.

• There is specific annual budget allocation for procurement, up-gradation, deployment and maintenance of the computers and their accessories. Maintenance of computers and their accessories are also done from the funds available in the college.

Administrative Setup: The Principal endeavors to allocate a variety of college obligations and tasks to the faculty, including both teaching and non-teaching staff, based on their interests, abilities, and aptitude. At the conclusion of each fiscal year, faculty members are required to complete a self-appraisal form, which is included in their annual confidential report. ## 6.3 Faculty Empowerment Strategies

#### 6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

#### **Response:**

The teaching and non-teaching members offer valuable support to the running of the institution. The institution offers a lot of welfare measures to its permanent teaching and non-teaching staff members. Most of these welfare systems are according to the guidelines as laid down under the service conditions and welfare measures of the state government of Uttarakhand. All permanent staff members can avail medical benefits for themselves and their dependent family members through Golden Card facility provided by state government employees. There are different kinds of leaves that the permanent teaching and non-teaching staff may avail, such as Earned Leave, Casual Leave, Medical Leave or Child Care Leave among others. Teaching staff can avail Duty Leave for attending Orientation and Refresher Courses, and Faculty Development Programmes, that is, for the purpose of their quality enhancement. Permanent teaching members can also avail Study Leave and Sabbatical Leave for Ph.D and other research projects. All leaves are governed by central government and state government rules. The institution provides pension, gratuity and other retirement benefits as per policy of the Government of Uttarakhand.

The Performance Appraisal System for teaching and non-teaching staff in the college is in strict accordance with the norms and rules as indicated in the guidelines issued by the UGC and Uttarakhand

government.

For teachers Career Advancement Schemes have been in place, as notified by the UGC from time to time. Uttarakhand government introduced the new API (Academic Performance Indicator) format through PBAS (Performance Based Appraisal System) based on UGC 2018 regulation adopted by Government. This new appraisal system encourages faculty to develop and enhance their professional and research skills so that they may further benefit by means of promotion to the next level. These skills may be attained through Orientation Programme/Faculty Induction Programme, Refresher Course and Faculty Development Programmes (FDPs), along with research, publications, and few other parameters. The various stages of teaching staff in the college are as follows – Assistant professor, Associate Professor, and Professor. All proposed appraisals pass through Screening Committee appointed by directorate of higher education Uttarakhand and selection committee appointed by department of higher education. After completing all due processes, the pay fixation is done by the Government of Uttarakhand as per the recommendations of the Pay Commission in place. Teachers can be promoted to **Principal** on recommendation of Departmental promotion committee based on their performance.

All initial posts for non-teaching staff are through direct recruitment by UKSSSC. These posts include –junior assistant, laboratory assistant, and library assistant. Service conditions of the non-teaching staff is as per Government of Uttarakhand guidelines. From the level of Junior Assistant, the next level of promotion is to Senior Assistant, principal assistant, administrative officer, senior administration Officer, and finally chief Administrative Officer through recommendations of Departmental promotion committee. The Laboratory Attendant can only be promoted to Laboratory Assistant. In case of Library, recruitment is based on both through direct recruitment or through promotion. Non-teaching staff also get benefit of Assured Career Progression Scheme (ACP).

## 6.4 Financial Management and Resource Mobilization

#### 6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

#### **Response:**

College get funds mainly from Government of uttarakhand and fee collected by college from students. Some specific cases college may get funds from Local M.L.A , local M.P, District authorities etc. The teachers, in charge of committees and department heads submit proposals and requirements to the principal, who then discusses them with senior faculty members to decide whether to accept or reject them. If a proposal is accepted, it is forwarded to the relevant committee for purchase consideration. In the event that the college lacks sufficient funds, a request for funding is made to the Directorate of Higher Education, District authorities, Local M.L.A or local M.P.

for example : In April 2021, the District Magistrate of U.S.Nagar in Uttarakhand sanctioned a budget of 10 lakh rupees to acquire books for the library, improve training facilities for NCC cadets, and establish 5 ICT-enabled classrooms.

Once the funds are secured, the purchase committee uses them to make purchases according to the proposal, while following the financial rules set by the government of Uttarakhand. The committee also ensures that the available funds are optimally utilized by publicly soliciting tenders and quotations.

College is selected under component seven of RUSA Phase -1 for the infrastructural development. Under component seven of RUSA Rs. 200 lakhs has been sanctioned from the MHRD, RUSA under XII Plan for the infrastructural improvement of the college. Sanctioned amount is further allocated in the ratio of 35:35:30 respectively under New construction, Up gradation & renovation work and for the New facilities to be added in the college. A project monitoring unit (PMU) and a board of governors (BOG) have been established to oversee this project.

In case of insufficient funds in a specific account, it is possible to allocate funds for a project from another account with the approval of the directorate or an empowered committee.

Internal and external Audit-

The A.G. office in Dehradun conducts periodic external financial audits, while internal audits are performed by the Directorate of Higher Education Uttarakhand.

- Vouchers support every transaction, Collections are deposited in the bank, and expenditures are incurred through cheques, both recurring and non-recurring.
- The assistant accountant maintains the internal accounts, while the Office Superintendent, headed by the Principal, oversees it.
- Proper purchasing procedures are followed. The Institution has established a Purchase Committee to call for quotations, compare prices, and follow proper purchasing procedures.
- Separate accounts are kept for each grant to optimize financial resources.
- Physical checks and verifications are performed on the Departmental Accession Register, Stock Registers, and Purchase Registers.

#### **Response:**

The Internal Quality Assurance Cell (IQAC) is responsible for monitoring and ensuring the quality of academic and administrative activities in educational institutions. To ensure the effective functioning of the IQAC, regular meetings are conducted to review the progress and identify areas for improvement. The planning for the next academic year is discussed, including the setting of goals, objectives, and strategies for quality assurance.

On recommendation of IQAC, following processes are started and later it become institutionalised-

- 3. Establishment of separate computer lab with sufficient number of computer and printer
- 4. Internet connection in each department.

- 7. Academic and administrative audit (AAA) in each department to assess the quality of teaching learning and functioning
- 8. Implementation of recommendation of AAA report
- 9. Efforts to Enhancement of infrastructure in department and laboratory
- 10. Collection of feedback from students and teachers on infrastructure and academics
- 11. Subscription of N-List
- 12. Organising seminars and conferences in college

The primary focus of IQAC has always been on improving the teaching-learning process through innovative methods. To achieve this goal, IQAC initiates various teaching and learning methods and reviews them at regular intervals to enhance the learning outcomes. To this end, IQAC conducts regular meetings to review and gather feedback. The feedback collected is analyzed, and appropriate measures are taken to upgrade the college with the necessary procedures. An online feedback link is also provided on the college website to facilitate the feedback process. At the beginning of each session, faculty members prepare a teaching plan and follow it. The organizer of any activity provides a report on the

outcomes to the principal and IQAC to identify areas for further improvement. The student's performance is assessed through various methods, including presentations, debates, online tests, class tests, quizzes, and internal exams, at regular intervals.

Title of the Practice 1

Environmental consciousness and sustainability

#### **Objectives of the Practice**

The college has taken a proactive approach to instill the environmental consciousness and sustainable development values in its students. The sole aim of this initiative is to achieve a visibly greener and cleaner college, with a significant contribution from the students and college staff and make them responsible citizens towards environment and sustainability.

#### The Context

Due to insecure boundaries of the campus, and using it as thoroughfare by villagers and animals, greenery of college has been reduced. To resolve this issue, the college administration decided to start afresh by launching a clean and green campus drive. Firstly, the college began an awareness campaign to communicate with the villagers and simultaneously approached the local administration to repair the campus boundaries. Secondly, the college initiated a plantation drive within the campus, involving students to raise awareness and sensitize them towards environmental issues. The college also decided to provide an area (**my corner/ Mera Kona**) to individual staff for maintaining the greenery of that specified area, within the campus with the help of students. This practice is reflected on top priority in all extra-curricular activities that revolve around environmental protection. The NSS/NCC/Rovers and Rangers events are all geared towards promoting the environment.

**The Practice** 

The college has decided to incorporate environmental consciousness as the centre in most of its programs to sensitize students, staff, and nearby villagers. Under NSS, several programs have been organized such as **Indian Sanitation Mission, Plastic Unmulan Day, Clean India Mission, Clean Campus and Green Campus, Pledge for Fit, maintenance of Botanical Garden, Cleanliness Drive, and World Sparrow Day**. Similarly, NCC cadets have organized programs such as **cleanliness drive and plantation** in college. The departmental councils have also conducted various competitions such as poster competition on **Global Warming, Essay Competition on Global Warming and Biodiversity**, Chart Competition on **Climate Change**, and so on. NCC/NSS / Rovers and Rangers unit conducted various outreach programs in the nearby area to educate people about the importance of the environment and the necessity of planting trees for the sustainability of future generations.

Additionally, a large number of plants were planted with the support of **local villagers, alumni and through CSR.** The abandoned land of the college has been made greener by planting more than 250 plants under **Mukhyamantri Navachar Yojna** and 300 trees through CSR. Teachers usually plants trees on the occasion of **Harela** and days of national importance. Teachers also took the task enthusiastically to keep the area clean provided them under "My Corner" initiative.

#### **Evidence of Success**

A significant portion of the college land was overgrown with bushes and had no practical use. But with the persistent effort of students and teachers, this land has been transformed into a lush green landscape. The establishment of a botanical garden and other green areas have been a significant benefit to the students, with an abundance of insects and a clean environment that is being utilized by Botany and Zoology post-graduate students for their project work.

#### **Problems Encountered and Resources Required**

Initially, there was a shortage of funds, but with collective efforts from students and staff, it has become a self-sustained practice.

#### **Title of the Practice 2**

Building a Sustainable Future: Transforming Plastic Waste into "Eco Bricks"

#### **Objectives of the Practice**

- **Plastic waste reduction**: By compacting single-use plastic into eco bricks, our objective is to divert plastic waste from household, landfills and waterways, mitigating its long decomposition period.
- Environmental awareness and educational opportunities: Through the practice of eco bricking, students and staff develop a deeper understanding of the environmental impact of plastic waste and its management.

- **Community involvement**: Encouraging unity and cooperation among students, faculty and society.
- **Sustainable infrastructure**: Utilizing eco bricks, college aims to construct diverse structures such as benches, planters, and small installations, reducing the demand for conventional building materials with a higher environmental footprint.

## The Context:

The eco brick concept involves compacting single-use plastic into dense building materials within plastic bottles. This unique practice in Uttarakhand's higher education promotes sustainability, waste management, and community engagement. By adopting eco bricks, our college addresses the significant environmental concern of single-use plastic waste in India while providing an eco-friendly alternative to traditional construction materials like bricks or concrete.

## The Practice:

Upon the college administration's decision to ban single-use plastics, teachers initiated a campus-wide cleanup campaign to address polythene waste. With the help of students, plastic waste was collected from the campus, and the idea of eco bricks was introduced. Students were encouraged to collect plastic waste in plastic bottles, leading to a movement that expanded beyond the campus. To support the initiative, interested students/ staff member submit their eco bricks to a designated collection point. For wide spread awareness, resources such as motivational videos, "selfies with my eco brick", video of making eco-brick campaigns, and workshops were organized.

## **Evidence of Success**:

The initial goal of making our campus polythene-free was swiftly achieved through the implementation of eco bricks. Additionally, the movement expanded to collect plastic waste from beyond the campus, which was transformed into eco bricks. These bricks have been utilized in various applications, such as creating borders for the botanical garden, seating stools in reading rooms, and other innovative projects. Students have embraced the initiative, creating colorful eco bricks as part of their activity. This practice not only contributes to a plastic-free environment but also instills a sense of community involvement and educates students about the importance of collective action. Overall, implementing eco brick making in our college showcases a unique and forward-thinking approach to sustainability and waste management in higher education in India.

## Problems Encountered and Resources Required:

- Inadequate communication and coordination initially led to confusion and hindered the collection process.
- Limited budgeting
- Variations in eco brick characteristics, such as shape, size, density, and sturdiness, affected their usability.

By addressing these challenges and allocating appropriate resources, our eco brick initiative can continue to thrive, making significant contributions to sustainable waste management and environmental conservation.
