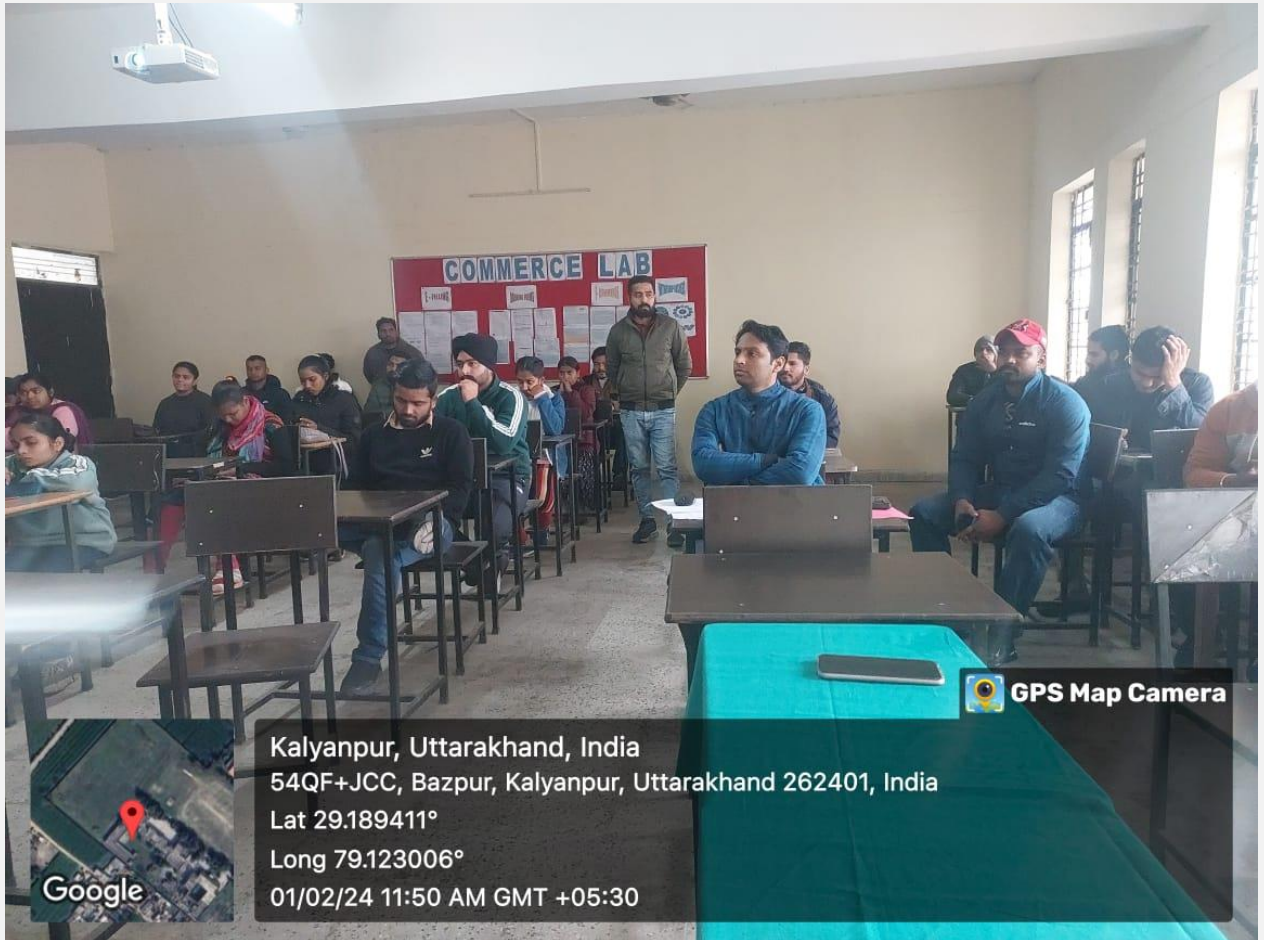
Conclusion:
